Submission of returns

As an approved tied oils trader whose estimated throughput exceeds 10,000 litres per annum, you are required to submit a completed and signed HO34 return to the Mineral Oil Reliefs Centre by the 14th day of the month following the end of each agreed accounting period. Multiple approved premises must be collated in a single consolidated return.

Your return period will cover the period 01-Jul-2016 to 31-Aug-2016 and will be quarterly thereafter.

Deliveries of tied oil

You must regularly check that your customers are correctly approved for the oils they wish to receive, in accordance with Notice 184A section 9
